Current measures on coronavirus (SARS-CoV-2)

Dear Sir or Madam,

Unfortunately, the coronavirus has now spread worldwide and it is expected that the number of cases of infection will continue to increase. This makes it all the more important for us to inform you as our customer in the best possible way and regularly about our current delivery situation.

Therefore, we would like to inform you in the following of the measures taken:

- → Implementation of strict protective measures and hygiene regulations for all employees
- -General travel ban
- Restricted personal contact with external business partners only absolutely necessary visits, e. g. contractual inspections, are permitted under observance of all codes of conduct according to the Robert Koch Institute Berlin!
- → Cancellation of all events and trade fairs

From today's point of view, the supply of raw materials, auxiliary materials and operating materials to our plants Netphen and Haiger is assured in the near future. We are therefore optimistic about the supply and delivery possibilities of our plants.

We have also contacted our suppliers to secure the supply chain and have asked for the following active support

- A continuous, robust and reliable analysis of their supply chain with a focus on sub-suppliers not only from China, but also from other vulnerable areas to actively identify critical components.
- → Determination of measures to ensure timely deliveries.
- → Active involvement of their main suppliers and the introduction of specific measures. In the event of a delay, we ask to indicate which products are delayed and when we can expect delivery.

However, due to the current situation we cannot completely rule out delivery delays in our supply chain caused by unforeseeable outages.

Should our ability to deliver change, we will continue to keep you informed of measures and impacts.
